Dear Nicole,

Congratulations on your acceptance into the Broward Cultural Division's Arts Education Directory! We are pleased to have you on our roster of talented arts and cultural education providers.

Broward Cultural Division (BCD) promotes the Arts Education Directory (AED) primarily through the programming and partnerships administered by its Education and Advocacy Section. Whenever and wherever possible, we cultivate demonstration, presentation and workshop opportunities for AED participants.

The partnership between the Children's Services Council of Broward County (CSC) and BCD is particularly noteworthy. It builds collaboration between CSC funded providers and AED participants, resulting in more exposure to the arts for children in CSC funded after-school and summer programs. CSC funded providers are required to use AED participants for any cultural arts programming offered through their agreement with the CSC. CSC providers determine the types of cultural arts programming most appropriate for their populations, and then contact AED participants who may be able to provide services. CSC providers negotiate directly with AED participants. BCD is not involved in the booking/fee negotiation process. Until your website listing is active, this letter will serve as confirmation of your participation in the Directory. We encourage you to present it to CSC providers and inform them of your services. To cultivate relationships, you might consider conducting complimentary demonstration workshops for providers. Demonstration workshops allow potential clients to gain first-hand experience with who you are and what you do.

You are also encouraged to apply for a BCD Community Arts Education Partnerships Grant. The purpose of the grant is to expand access to arts education occurring in community-based settings. Projects may include performances by or exhibitions of professional artists; arts instruction; arts intervention; healing/expressive arts; and arts integration projects that promote the development of knowledge, skills, or appreciation related to arts and culture. An individual artist or community-based educator living within Broward, Miami-Dade, Monroe, Palm Beach, or Martin County who has conducted an arts educational, community arts, and/or community design project in the year immediately preceding the date of application, and who is collaborating with one (1) or more eligible entities (non-school, Broward County-based public entities and non-profit organizations).
